Independent School District # 553, New York Mills, Minnesota requests sealed bids for the sale of a student built house.

The house is of all new construction and is open for inspection during regular working hours 8:00 to 4:00 by calling 218-385-4211 and setting up an appointment with Construction Class Instructor, Eric Niemi.

A bid packet is available with specifics. All applicable sales tax is the responsibility of the bidder.

Bids will be received up to 3:30 p.m., Wednesday, May 16, 2018, in the district office located at 209 Hayes St., New York Mills MN 56567. They may be mailed to Marsha Maki Business Manager, New York Mills ISD #553, PO Box 218, New York Mills, MN 56567. Bids must be sealed and marked "Bid for Purchase of House".

The school district reserves the right to accept or reject any and all bids, to set a minimum sale price and to waive irregularities in bid proposals. House must be removed from school property before August 1, 2018.

BID PROCEDURE

1. Bids will be accepted by School District 553 until May 16, 2018, at 3:30 pm. Minimum Bid Established is \$61,830 which includes 7.375% sales tax.
2. Complete the attached bid form, seal your bid in the enclosed envelope and submit to:

3. Tender the offer with a certified cashier's check, or bank money order in the amount of 5% of the total bid. Check payable to: School District 553.
4. One bid submitted per person.
5. Purchase of the house is subject to Minnesota 7.375% State and County Sales Tax which is included in the minimum bid price.
6. School District 553 reserves the right to reject any or all bids or waive all informalities.
7. District 553 School Board will accept the high bid at the May 21st board meeting. On May 23, 2018 the deposits of unsuccessful bidders will be returned.
8. The house will be sold as is. All house specifications are built as approved by the State of MN building codes.
9. The successful bidder must pay with a certified cashier's check or bank money order for the remaining bid price no later than June 15, 2018 and properly insure the house once the house is paid for.
10. The successful bidder must move the house at their expense from ISD #553 building site by August 1, 2018. The successful bidder will be responsible for paying a \$1,000 surcharge on August 15, 2018 and every 30 days thereafter until the house is moved. The house cannot be moved or prepared for moving until full payment has been received. After full payment, all risk of loss, of any nature whatsoever, is the buyer's responsibility. These move dates are negotiable, in part because the school parking lot will be under construction during 2018.
11. If the successful bidder fails to fulfill the contract, the 5% down payment will be forfeited.
12. The buyer must obtain any and all necessary moving and local permits.
13. The buyer must assume all responsibility for any damage to property in the moving of the house.
14. This purchase does not include any cement blocks, timbers, or lumber below the floor joists, stairs, or entry platforms.

Below are several steps that must be considered before buying the house.

1. Arrange financing.
2. Secure a lot for the house.
3. Secure permits in the community where the house will be located. Contact the building officials in the community for details.
4. Contact house movers regarding the cost of moving the house to your site. A list of movers is included.
5. Contact excavating contractor for cost on digging a basement.
6. Contact masonry contractor for cost on basement walls and other masonry work.
7. Contact plumbing company.
8. Contact electrical company.
9. Contact heating & cooling contractor to receive cost on heating and cooling units, duct and vent work.

The house is located on the North side of District 553 New York Mills High School, 209 Hayes Street, New York Mills, MN 56567.
